All of us start the new year afresh. We make resolutions. I can't starve myself trying to lose weight...but I could cut out snacks between meals as a start. Again, an achievable step. I might want to read more, so I can start by reading a chapter a day in a book. You get the idea. The resolution has to be reasonable, achievable, and specific.

Now here is one resolution that is reasonable, achievable, and specific: Resolve to meet with me to update the information on your family's financial needs analysis. (Or maybe you need to complete a financial needs analysis.) Let's see where you stand. Your financial health is critical to your family's future security.
